**[Handling personal Information]**

- 1、 Personal information provided will be handled appropriately in accordance with the Yokohama City Personal Information Protection Ordinance.
- 2、 The collection, use, and store of personal information is implemented by the city of Yokohama and the facility manager.
- 3、 Personal information provided will be strictly stored in a safety box for 30 days from the date of use. It will also be disposed of appropriately after the storage period has elapsed.
- 4、 We will not use personal information or provide to third parties without obtaining consent for any purpose other than the purpose of preventing new coronavirus infection. Except in the following cases:
  - (1) When an administrative agency requests disclosure of information in accordance with laws and regulations
  - (2) When the City of Yokohama determines that it is urgent and inevitable to protect a person's life, body or property.
